PARTIES

- 1 **HERON UK BIDCO LIMITED**, a company incorporated in England and Wales whose registered office is at 72 Welbeck Street, London W1G 0AY ("**Offeror**"); and
- 2 **HYVE GROUP PLC**, a company incorporated in England and Wales whose registered office is at 2 Kingdom Street, London, England, W2 6JG ("**Hyve**").

BACKGROUND

- A The Offeror intends to announce a firm intention to make a recommended offer for the entire issued and to be issued share capital of Hyve (the "Acquisition") to be implemented by way of a Scheme or, if the Panel consents, by way of an Offer, on the terms and subject to the conditions set out in the Announcement.
- B The parties are entering into this agreement to take certain steps to implement the Acquisition and wish to record their respective obligations relating to such matters.

AGREEMENT

- 1 Definitions and interpretation
- 1.1 The background section and schedules form part of this agreement and shall have the same force and effect as if set out in the body of this agreement. Any reference to this agreement shall include the background section and schedules.
- 1.2 In this agreement, the following words and expressions have the following meanings:

Acceptance Condition: the acceptance condition to any Offer;

Acquisition: has the meaning given to it in Recital (A);

Act: the Companies Act 2006;

Agreed Switch: has the meaning given to it in clause 7;

Announcement: the announcement detailing the terms and conditions of the Acquisition to be made under Rule 2.7 of the Code in substantially the form set out in schedule 2 (*Announcement*) to this agreement (subject to any such changes prior to publication as may be agreed by, or on behalf of, Hyve and the Offeror);

Awards: has the meaning given to it in paragraph 1.1 of part 1 of schedule 1;

Business Day: any day which is not a Saturday, a Sunday or a public holiday in London;

Clearance: all filings having been made and all or any applicable waiting periods (including any extensions thereof or any time periods set forth in any timing agreements with the United States antitrust authorities) under the HSR Act and the rules and regulations thereunder having expired or been terminated as applicable in each case in respect of the Acquisition, or any matters arising from the Acquisition;

CMA: has the meaning given to it in clause 3.4;

Code: the City Code on Takeovers and Mergers as amended and interpreted by the Panel;

Conditions means:

(a) for so long as the Acquisition is being implemented by means of the Scheme, the terms and conditions to the implementation of the Acquisition as set out in Appendix I to the

Announcement (as may be amended by agreement in writing between the Offeror and Hyve and, where required, with the consent of the Panel); or

(b) if the Acquisition is implemented by means of an Offer, the conditions referred to in (a) above, as amended by replacing the Scheme Conditions with the Acceptance Condition, and as may be further amended by agreement in writing between the Offeror and Hyve and, where required, in either case, with the consent of the Panel;

Confidentiality Agreement: the confidentiality agreement between Providence Equity LLP and Hyve in relation to the Acquisition dated 13 February 2023;

Court: the High Court of Justice in England and Wales;

Court Meeting: the meeting or meetings of Hyve Shareholders to be convened by order of the Court under the Act for the purpose of considering, and, if thought fit, approving the Scheme (with or without amendment), including any postponement or adjournment thereof, notice of which is to be contained in the Scheme Document;

disclosing party: has the meaning given to it in clause 5.1

DSBP: the Hyve Deferred Share Bonus Plan;

Effective Date: the date upon which:

- (a) the Scheme becomes effective in accordance with its terms; or
- (b) in the event of a Switch, the Offer becomes or is declared unconditional;

FCA: the UK Financial Conduct Authority;

General Meeting: the general meeting (including any adjournment(s) or postponement(s) thereof) of Hyve Shareholders to be convened in connection with the Scheme for the purpose of considering, and, if thought fit approving, the Hyve Resolutions;

HHL Articles: the articles of association of Hyve Holdings Limited;

HSR Act: the United States Hart-Scott-Rodino Antitrust Improvements Act of 1976, as amended:

Hyve Board Recommendation: a unanimous and unqualified recommendation from the Hyve Directors: (i) that Hyve Shareholders vote in favour of the Scheme at the Court Meeting and the Hyve Resolutions at the General Meeting; or (ii) in the event of a Switch, that Hyve Shareholders accept the Offer, as the case may be;

Hyve Board Recommendation Change means:

- (a) if Hyve makes an announcement prior to the publication of the Scheme Document that:
 - the Hyve Directors no longer intend to make the Hyve Board Recommendation or that the Hyve Directors intend to withdraw, adversely to modify or qualify the Hyve Board Recommendation;
 - (ii) it shall not convene the Court Meeting or the General Meeting (or shall convene such meetings and adjourn or postpone them without in such announcement specifying a date for reconvening them within 15 Business Days following the originally scheduled date for such Court Meeting or General Meeting); or
 - (iii) it intends not to publish the Scheme Document; or
- (b) any failure to include the Hyve Board Recommendation in the Scheme Document;

- (c) Hyve makes an announcement that it will delay the convening of, or will adjourn, the Court Meeting or the General Meeting to a date which is later than the latest date permitted by Condition 2(a)(ii) or Condition 2((b))(ii) respectively in each case without the consent of the Offeror;
- (d) the Hyve Directors withdraw, or adversely modify or qualify, the Hyve Board Recommendation (provided, however, that an announcement by the Hyve Directors that any transaction contemplated in paragraph (e) below, or any proposal in respect of a possible offer or firm offer for Hyve, is under consideration by the Hyve Board, shall not of itself constitute a withdrawal, or adverse modification or qualification, of the Hyve Board Recommendation unless the Hyve Directors fail to announce, within three Business Days of the announcement that such a transaction is under consideration by the Hyve Directors, its reconfirmation of the Hyve Board Recommendation); or
- (e) if Hyve announces the entry into by any member of the Hyve Group of any agreement (whether conditional or unconditional) to effect a transaction that would constitute:
 - (i) a reverse takeover of Hyve (as defined by the Code); or
 - except where the Offeror has given its prior written consent to such transaction, a class 1 transaction for, or a reverse takeover of, Hyve (each as defined in the Listing Rules);
- (f) if, after the Scheme has been approved by Hyve Shareholders and/or the approval of the Hyve Resolutions at the General Meeting:
 - (i) the Hyve Directors announce that they shall not implement the Scheme (other than in connection with an announcement of an Offer by the Offeror or one of its concert parties for Hyve); or
 - (ii) a third party announces a firm intention under the Code to make an offer or revised offer (whether or not it is subject to the satisfaction or waiver of any pre-conditions) for Hyve which is recommended by the Hyve Directors;

Hyve Directors: the directors of Hyve from time to time;

Hyve EBT: has the meaning given to it in paragraph 6.1 of part 1 of schedule 1;

Hyve Group: Hyve and its subsidiaries and subsidiary undertakings from time to time and member of the Hyve Group shall be construed accordingly;

Hyve Remuneration Committee: means the remuneration committee of the board of directors of Hyve;

Hyve Representative: has the meaning given to it in clause 12.3;

Hyve Resolutions: such shareholder resolutions of Hyve to be proposed at the General Meeting for the purposes of, among other things, approving and implementing the Scheme, adopting the Amended Hyve Articles, and such other matters as may be agreed between Hyve and the Offeror as necessary or desirable for the purposes of implementing the Scheme;

Hyve Share Plans: the PSP, the DSBP and the VCP;

Hyve Shareholders: the registered holders of Hyve Shares from time to time;

Hyve Shares: ordinary shares of 10 pence each in the capital of Hyve;

Law: any applicable statutes, common law, rules, ordinances, regulations, codes, orders, judgments, injunctions, writs, decrees, directives, governmental guidelines or interpretations having the force of law or bylaws;

Listing Rules: the listing rules made by the FCA under section 73A of the Financial Services and Markets Act 2000, as amended from time to time;

Long Stop Date: 15 September 2023 (or such later date as the Offeror and Hyve may, with the consent of the Panel, agree and, if required, the Court may allow);

Notice: has the meaning given to it in clause 15;

Offer: means, subject to the terms of this agreement and if the Panel consents, the implementation of the Acquisition by way of a takeover offer (as that term is defined in Chapter 3 of Part 28 of the Act) by the Offeror, or an affiliate thereof, to acquire the entire issued and to be issued share capital of Hyve including, where the context admits, any subsequent revision, variation, extension or renewal of such offer;

Offer Document: the document sent (among others) to Hyve Shareholders pursuant to which any Offer would be made;

Offeror Directors: the directors of the Offeror from time to time and "**Offeror Director**" shall be construed accordingly;

Offeror Group: Providence and its affiliates and "member of the Offeror Group" shall be construed accordingly;

Panel: the Panel on Takeovers and Mergers;

parties: the parties to this agreement, and each, a "party";

Proposals: has the meaning given to it in paragraph 3.1 of part 1 of schedule 1;

Providence: Providence Equity Partners L.L.C.;

PSP: the Hyve Employee's Performance Share Plan 2014;

PSP Options: has the meaning given in paragraph 5.1 of part 1 of schedule 1;

Qualifying Termination: has the meaning given in 3.2 of part 2 of schedule 1;

receiving party: has the meaning given to it in clause 5.1;

restricted information: has the meaning given to it in clause 5.1;

Regulatory Authority: each relevant government or governmental, quasi-governmental, supranational, statutory, regulatory, administrative, environmental, professional or investigative body, court, trade agency, association, institution, any entity owned or controlled by any relevant government or state, or any other body or person whatsoever in any jurisdiction, and "**Regulatory Authorities**" means all of them;

Regulatory Conditions: the Conditions set out in paragraphs 3(a) to 3(d) of Appendix I to the Announcement (if and to the extent that, in the case of paragraphs 3(b) to 3(d), the relevant third party under that Condition is a Regulatory Authority);

Regulatory Information Service: a Regulatory Information Service as defined in the FCA Handbook:

Run-Off Cover: has meaning given to it in clause 10.2;

Sanction Hearing: the hearing by the Court of the application to sanction the Scheme under Part 26 of the Act;

Scheme: the proposed scheme of arrangement under Part 26 of the Act between Hyve and Hyve Shareholders, with or subject to any modification, addition or condition approved or

imposed by the Court and agreed by Hyve and the Offeror, pursuant to which the Acquisition is proposed to be implemented;

Scheme Conditions: those terms and conditions referred to in limb (a) of the definition of "Conditions" of this agreement;

Scheme Document: the circular to be sent (among others) to Hyve Shareholders setting out, among other things, the full terms and conditions of the Scheme and the notices convening the Court Meeting and the General Meeting, including any supplemental circular or document required by Law or any Regulatory Authority to be published in connection with such circular;

Scheme Record Time: has the meaning given to it in the Announcement;

Senior Facility Agreement: the senior term and revolving facilities agreement originally dated 1 October 2022 between, among others, Hyve as the Parent, Global Loan Agency Services Limited as agent and GLAS Trust Corporation Limited as security agent, as amended, novated, supplemented, extended or restated from time to time;

Significant Interest: in relation to an undertaking, a direct or indirect interest of 20 per cent. or more of the total voting rights conferred by the equity share capital (as defined in section 548 of the Companies Act) of such undertaking;

Switch: has the meaning given to it in clause 7;

VCP: the Hyve Value Creation Plan 2021;

VCP Shares: the A Shares (as defined in the HHL Articles) held in Hyve Holdings Limited pursuant to the VCP;

Wider Providence Group: Providence, funds advised by Providence and their respective subsidiary undertakings and associated undertakings and any other body corporate, partnership, joint venture or person in which Providence and/or such undertakings (aggregating their interests) have a Significant Interest and "**member of the Wider Providence Group**" shall be construed accordingly.

- 1.3 In this agreement, unless otherwise specified:
 - 1.3.1 terms used but not defined expressly in this agreement shall, unless the context otherwise requires, have the meaning given to them in the Announcement but, in case of inconsistency, the definitions set out in this agreement shall take precedence;
 - any reference to any statute or statutory provision includes any subordinate legislation made under that statute or statutory provision, whether before, on, or after the date of this agreement;
 - 1.3.3 any reference to any legislation (whether of the United Kingdom or elsewhere), including to any statute, statutory provision or subordinate legislation ("**Legislation**"), includes a reference to that Legislation as from time to time amended or re-enacted, whether before, on, or after the date of this agreement;
 - 1.3.4 except where expressly stated otherwise in this agreement, any consent or approval required from a person is at the absolute discretion of that person;
 - 1.3.5 words and expressions which are defined in the Act and which are not otherwise defined in this agreement shall have the same meanings as are given to them in that Act;
 - 1.3.6 any gender includes a reference to the other genders;
 - 1.3.7 use of the singular includes the plural and vice versa;

- 1.3.8 any reference to "holding company" or "subsidiary" or "subsidiary undertaking" have the respective meanings given to them in the Act save that:
 - 1.3.8.1 a company shall be treated, for the purposes only of the membership requirement contained in ss.1159(1)(b) and (c) of the Act, as a member of another company if it beneficially owns shares in that other company which are registered in the name of: (i) another person (or that person's nominee), whether by way of security or in connection with the taking of security, or (ii) its nominee;
 - 1.3.8.2 in the case of a limited liability partnership which is a subsidiary of a company or another limited liability partnership, s.1159 of the Act shall apply as if: (i) references in ss.1159(1)(a) and (c) of the Act to voting rights are to the members' rights to vote on all or substantially all matters which are decided by a vote of the members of the limited liability partnership; and (ii) the reference in s.1159(1)(b) of the Act to the right to appoint or remove a majority of its board of directors is to the right to appoint or remove members holding a majority of the voting rights;
- 1.3.9 any reference to any other document is a reference to that other document as amended, varied, supplemented, restated, adhered to or novated (in each case, other than in breach of the provisions of this agreement or such other document) at any time; and
- 1.3.10 any phrase introduced by the terms "including", "include", "in particular" or any similar expression shall be construed as illustrative and shall not limit the sense of the words preceding those terms;
- the expressions "acting in concert", "concert parties", "control" and "offer" shall be construed in accordance with the Code;
- any reference to "persons" includes natural persons, partnerships, companies, bodies corporate, associations, organisations, governments, states, foundations and trusts (in each case, whether or not having separate legal personality);
- 1.3.13 references to times of day are to London time, unless otherwise stated;
- 1.3.14 unless otherwise defined in this agreement, terms defined in the Announcement have the same meanings when used in this agreement.

2 Effective Date and terms of the Acquisition

2.1 Effective Date

The obligations of the parties under this agreement, other than clause 1, this clause 2.1 and clauses 11 to 25 (inclusive), shall be conditional on the release of the Announcement via a Regulatory Information Service on or before 15 March 2023, or such other date as may be agreed by the parties. Clause 1, this clause 2, and clauses 11 to 25 (inclusive) shall take effect on and from the time when this agreement is entered into by all of the parties to it.

2.2 Terms of the Acquisition

2.2.1 The principal terms of the Acquisition shall be as set out in the Announcement, together with such other terms as may be agreed between Hyve and the Offeror in writing (save in the case of an improvement to the terms of the Acquisition, which shall be at the sole discretion of the Offeror) and, where required by the Code, approved by the Panel.

2.2.2 The terms of the Acquisition at the date of publication of the Scheme Document shall be set out in the Scheme Document. Should the Offeror elect to implement the Acquisition by way of an Offer in accordance with this agreement, the terms of the Acquisition shall be as set out in the announcement of the switch to an Offer, the Offer Document and any form of acceptance of such Offer.

3 Undertakings to cooperate and satisfy the Conditions

3.1 Offeror's Regulatory Conditions strategy

Except where otherwise required by Law or a Regulatory Authority, the Offeror shall:

- 3.1.1 determine, having consulted in good faith with Hyve in a timely manner, the strategy to be pursued for satisfying the Regulatory Conditions; and
- 3.1.2 contact and correspond with any Regulatory Authority in relation to the satisfying of a Regulatory Condition sought by the Offeror in respect of the Acquisition in accordance with this agreement, including submitting and preparing, with the assistance of Hyve in accordance with this agreement, all necessary filings, notifications and submissions.

3.2 Hyve co-operation in respect of Regulatory Conditions

Hyve undertakes to co-operate in a timely manner with the Offeror for the purposes of satisfying any Regulatory Conditions, including:

- 3.2.1 upon request from the Offeror, providing the Offeror with such access to Hyve's management and any information or documents as may be reasonably required for the purpose of making a submission, filing or notification to any relevant Regulatory Authority in relation to a Regulatory Condition as soon as practicable;
- 3.2.2 providing all such other non-financial assistance as may be reasonably required by the Offeror for the purposes of obtaining the Clearance and any other required official authorisations in order to satisfy the Regulatory Conditions,

provided that nothing in this clause 3 shall require the directors of Hyve to:

- 3.2.3 maintain the Hyve Board Recommendation;
- 3.2.4 adjourn, postpone or seek to adjourn or postpone (or refrain from adjourning or postponing or seeking to adjourn or postpone) any shareholder meeting or court hearing which has been or shall be convened in relation to the Acquisition; or
- 3.2.5 without prejudice to any other obligation Hyve has under this agreement, require Hyve to make any change (or refrain from making any change) to the timetable for implementing the Acquisition.

3.3 Offeror undertaking to satisfy Regulatory Conditions

The Offeror shall use all reasonable endeavours to satisfy the Regulatory Conditions as soon as is reasonably practicable and, in any event, by the Long Stop Date.

3.4 No additional filings to Regulatory Authorities

Each of the Offeror and Hyve shall not, and shall procure that each member of the Offeror Group or Hyve Group, respectively and any person acting in concert or deemed to be acting in concert with it shall not, without the prior written consent of the other party (such consent not to be unreasonably withheld or delayed), make any filings, notifications or submissions to a Regulatory Authority in relation to the Acquisition, other than those which are required in relation to the satisfaction of the Regulatory Conditions or are otherwise contemplated by this agreement. Nothing in this clause shall prevent the Offeror Group from choosing, at its own

discretion, to submit a briefing note to the UK Competition and Markets Authority (the "CMA") pursuant to Section 3 of the CMA's guidance on its mergers intelligence function. In the event the Offeror Group does choose to submit such a briefing note, Hyve shall have the right to review it and make reasonable submissions in respect of its contents.

3.5 Offeror co-operation with Hyve

Without prejudice to clause 3.3, the Offeror undertakes (if and to the extent that such steps have not already been taken prior to the date hereof) to:

- 3.5.1 provide Hyve (or its advisers) with draft copies of all material filings, notifications, submissions and written communications to be made to any Regulatory Authority by or on behalf of the Offeror in relation to obtaining any Clearance, at such time as shall allow Hyve a reasonable opportunity to provide comments on such filings, notifications, submissions and communications before they are submitted or sent;
- 3.5.2 give due consideration to such comments made by Hyve as are reasonable on such material filings, notifications, submissions and written communications;
- 3.5.3 make Offeror Group representatives available for meetings and material telephone calls with any Regulatory Authority if requested by Hyve;
- 3.5.4 make Offeror Group representatives available for meetings and material telephone calls requested by any Regulatory Authority where the presence of such representatives have been requested by that Regulatory Authority, or otherwise deemed by Hyve on a reasonable basis to be necessary or desirable, in connection with the obtaining of any Clearance and the implementation of the Acquisition;
- 3.5.5 provide Hyve (or its advisers) with copies of all material filings, notifications, submissions and written communications in the form submitted or sent to any Regulatory Authority by or on behalf of the Offeror in relation to obtaining any Clearance; and
- give Hyve reasonable prior notice of and, to the extent permitted by the relevant 3.5.6 Regulatory Authority, allow persons nominated by Hyve to attend all meetings and/or material telephone calls with any Regulatory Authority in connection with the obtaining of any Clearance and to make reasonable oral submissions during such meetings and/or telephone calls (provided such oral submissions have been discussed by the parties in advance) and provided always that, where the Offeror reasonably deems that such meeting and/or telephone call involves or may involve the disclosure of personal information, commercially sensitive information and/or information that the Offeror is prohibited by Law or contractual arrangements from disclosing to Hyve (including information about limited partners of members of the Wider Providence Group), Hyve shall be excluded from all or part of such meeting and/or telephone call (as applicable), although, for the avoidance of doubt, this clause does not prevent external legal advisers nominated by Hyve from attending such meeting and/or telephone call, on the understanding that they shall not disclose any such information to Hyve;
- 3.5.7 subject to clauses 3.1.2, 3.3 and 3.4, make as promptly as practicable any filings with any Regulatory Authority in connection with the Regulatory Conditions and any other filing as agreed between the parties as necessary for the implementation of the Acquisition;
- 3.5.8 subject to clauses 3.1.2, 3.3 and 3.4, respond as promptly as practicable to any requests for information received from any Regulatory Authority in connection with the Regulatory Conditions, and in any case by the relevant deadline specified by the relevant Regulatory Authority;

- 3.5.9 keep Hyve informed as promptly as is reasonably practicable of developments which are material or potentially material to the obtaining the Clearance and/or the satisfaction of the Regulatory Conditions;
- 3.5.10 notify Hyve promptly of, and promptly provide copies to Hyve of, any material communications (or, in the case of non-written material communications, reasonable details of the contents of any such material communications) from any Regulatory Authority in relation to obtaining the Clearance;
- 3.5.11 use, and procure that each member of the Offeror Group shall use, reasonable endeavours to avoid: (i) any declaration of incompleteness by a Regulatory Authority; and (ii) any suspension of review period by a Regulatory Authority; and
- 3.5.12 not, and procure that each member of the Offeror Group shall not, withdraw a filing, submission or notification to any Regulatory Authority, without Hyve's prior written consent (such consent not to be unreasonably withheld or delayed).

3.6 Submissions to Regulatory Authorities by Hyve

Save to the extent prohibited from doing so by Law or applicable Regulatory Authorities, Hyve undertakes to:

- 3.6.1 provide the Offeror (or its advisers) with draft copies of all material filings, notifications, submissions and written communications to be made to any Regulatory Authority by or on behalf of Hyve or any member of the Hyve Group in relation to obtaining any Clearance, at such time as shall allow the Offeror a reasonable opportunity to provide comments on such filings, notifications, submissions and written communications before they are submitted or sent;
- 3.6.2 give due consideration to such comments made by the Offeror as are reasonable on such material filings, notifications, submissions and written communications;
- 3.6.3 make Hyve Group representatives available for meetings and material telephone calls requested by any Regulatory Authority where the presence of such representatives have been requested by that Regulatory Authority, or otherwise deemed by the Offeror on a reasonable basis to be necessary or desirable, in connection with the obtaining of any Clearance and the implementation of the Acquisition;
- 3.6.4 provide the Offeror (or its advisers) with copies of all material filings, notifications, submissions and written communications in the form submitted or sent to any Regulatory Authority by or on behalf of Hyve in relation to obtaining any Clearance:
- 3.6.5 give the Offeror reasonable prior notice of and, to the extent permitted by the relevant Regulatory Authority, allow persons nominated by the Offeror to attend all meetings and/or material telephone calls with any Regulatory Authority in connection with the obtaining of any Clearance and the implementation of the Acquisition and to make reasonable oral submissions during such meetings and/or telephone calls (provided such oral submissions have been discussed by the parties in advance), provided always that, where Hyve reasonably deems that such meeting and/or telephone call involves or may involve the disclosure of personal information, commercially sensitive information and/or information that Hyve is prohibited by Law or contractual arrangements from disclosing to the Offeror, the Offeror shall be excluded from all or part of such meeting and/or telephone call (as applicable) although, for the avoidance of doubt, this clause does not prevent external legal advisers nominated by the Offeror from attending any such meeting and/or telephone call, on the understanding that they shall not disclose any such information to the Offeror;

- 3.6.6 keep the Offeror informed as promptly as is reasonably practicable of developments which are material to the obtaining of the Clearance and/or the satisfaction of the Regulatory Conditions; notify the Offeror promptly of, and promptly provide copies of, any material communications (or, in the case of non-written material communications, reasonable details of the contents of any such material communications) from any Regulatory Authority in relation to obtaining the Clearance;
- 3.6.7 use, and procure that each member of the Hyve Group shall use, reasonable endeavours to avoid: (i) any declaration of incompleteness by a Regulatory Authority; and (ii) any suspension of review period by a Regulatory Authority; and
- 3.6.8 not, and procure that each member of the Hyve Group shall not, withdraw a filing, submission or notification to any Regulatory Authority, without the Offeror's prior written consent (such consent not to be unreasonably withheld or delayed).

3.7 Filing fees and charges

The Offeror shall be responsible for paying or procuring payment of any filing, administrative or other merger notice fees incurred in connection with obtaining any Clearance, unless such fees are payable by Hyve as specified by applicable Law, in which case the Offeror shall, on demand, promptly reimburse Hyve for such fees.

3.8 Offeror actions which could prevent or delay satisfaction of the Regulatory Conditions

The Offeror undertakes to Hyve that, until the Regulatory Conditions are satisfied:

- 3.8.1 it shall not (and shall procure that each member of the Offeror Group shall not) take, or omit to take, or permit or cause to be taken or omitted to be taken, any action, or enter into an agreement for, or consummate, any acquisition or other transaction which would, or would be reasonably likely to, have the effect of preventing or materially delaying satisfaction of the Regulatory Conditions; and
- it shall, in each case to the extent permitted by applicable Law and any applicable obligations of confidentiality, inform Hyve promptly in the event that it becomes aware of any member of the Wider Providence Group entering into an agreement for, or consummating, any acquisition or other transaction which would, or would reasonably be expected to, have the effect of preventing or materially delaying satisfaction of the Regulatory Conditions.

4 Hyve documentation

- 4.1 If the Acquisition is being implemented by means of the Scheme, the Offeror agrees:
 - 4.1.1 to provide promptly to Hyve all such information about itself, the Wider Providence Group and its directors as may be reasonably requested by Hyve (or its advisers) for the purpose of inclusion in the Scheme Document (including all information for the purposes of satisfying the relevant disclosure obligations under the Code and/or applicable Law);
 - 4.1.2 to provide all such other assistance as may be reasonably required by Hyve for the preparation of the Scheme Document, including access to, and ensuring that reasonable assistance is provided by, the Offeror's professional advisers and members of the Wider Providence Group;
 - 4.1.3 to procure that the Offeror Directors (and any other person connected with the Offeror as required by the Panel) accept responsibility for all information in the Scheme Document relating to the Offeror, the Wider Providence Group and the Offeror Directors, including any statements of opinion, belief or expectation of the Offeror Directors in relation to the Acquisition or the Wider Providence Group

(including the Offeror's intentions for the Offeror Group as enlarged by the Acquisition following completion of the Acquisition) and any other information in the Scheme Document for which an offeror would be required under the Code or applicable regulations to accept responsibility; and

- 4.1.4 that, if any supplemental circular or document is required to be published in connection with the Scheme or, subject to the prior written consent of the Offeror (such consent not to be unreasonably withheld or delayed), any variation or amendment to the Scheme, it shall promptly provide, and shall procure that any member of the Wider Providence Group shall promptly provide, such cooperation and information necessary to comply with all regulatory provisions as Hyve may reasonably request in order to finalise such document.
- 4.2 Without prejudice to clause 9.3, the Offeror shall allow Hyve reasonable opportunity to provide comments on written communications to Hyve employees or share plan participants in connection with the Acquisition, and shall consider in good faith Hyve's reasonable comments on such communications.

5 Qualifications

- 5.1 Nothing in clause 3 shall require any person (the "disclosing party") to provide or disclose to another person (the "receiving party") any information:
 - 5.1.1 which the disclosing party (acting reasonably) considers to be commercially or competitively sensitive or confidential information related to its business and/or any member of the Wider Providence Group or the Hyve Group (as applicable) which is not relevant to the Acquisition or any Clearance;
 - that is personally identifiable information of a director, officer or employee of the disclosing party or any member of the Wider Providence Group or the Hyve Group (as applicable), unless that information can be reasonably anonymised (in which case the disclosing party shall provide the relevant information on an anonymous basis);
 - 5.1.3 which the disclosing party is prohibited from disclosing by Law or a Regulatory Authority:
 - 5.1.4 where such disclosure would result in the loss of any privilege that subsists in relation to such information (including but not limited to legal advice privilege); or
 - 5.1.5 in circumstances that would result in that party being in breach of a contractual obligation,

(the "restricted information").

A disclosing party may redact restricted information from any documents shared pursuant to this agreement and/or take reasonable steps to procure that restricted information is not shared with the receiving party, including, where relevant, where disclosure to the receiving party would reasonably be expected to have a material adverse effect on the disclosing party's legitimate business interest.

6 Implementation

- 6.1 The Offeror and Hyve agree that, if:
 - 6.1.1 the Scheme has been approved by the requisite majority of Hyve Shareholders at the Court Meeting;
 - the Conditions (other than the outstanding Scheme Conditions) have been duly satisfied or waived, and the Offeror has notified Hyve in writing of this fact; and

6.1.3 the Hyve Resolutions necessary in order to implement the Scheme have been duly passed by the requisite majority of Hyve Shareholders at the General Meeting,

and, unless (a) the Offeror has sought or intends to seek to invoke a Condition and delivered written notice of that fact to Hyve in accordance with clause 6.2 and (b) the Panel has either permitted the Offeror to invoke such Condition or not then determined whether it will permit the Offeror to invoke such Condition (at any time prior to the Sanction Hearing), then the Offeror shall:

- 6.1.4 not object to, and shall co-operate with, Hyve taking all the necessary steps to procure that the Sanction Hearing is held as soon as reasonably practicable;
- 6.1.5 not object to, and shall co-operate in relation to, the Scheme being implemented as soon as reasonably practicable; and
- at the Sanction Hearing, through counsel, agree to be bound by and consent to the implementation of the Scheme.
- 6.2 If the Offeror intends to invoke a Condition, the Offeror shall inform in writing Hyve as soon as reasonably practicable.

7 Switching to an Offer

- 7.1 The Offeror reserves the right, as set out in the Announcement and subject to the consent of the Panel, to elect at any time to implement the Acquisition by way of an Offer, whether or not the Scheme Document has been published (such election being a "Switch"), if:
 - 7.1.1 Hyve provides its prior written consent (an "Agreed Switch"); or
 - 7.1.2 a third party announces a firm intention to make an offer (whether or not subject to the satisfaction or waiver of any conditions or pre-conditions as allowed under the Code) for the issued and to be issued ordinary share capital of Hyve;
 - 7.1.3 a Hyve Board Recommendation Change occurs;
 - 7.1.4 save with the consent of the Offeror, either:
 - 7.1.4.1 the Court Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between the Offeror and Hyve with the consent of the Panel and the approval of the Court (if such consent and/or approval is required)); or
 - 7.1.4.2 the General Meeting is not held on or before the 22nd day after the expected date of such meeting as set out in the Scheme Document (or such later date as may be agreed in writing between the Offeror and Hyve with the consent of the Panel and the approval of the Court (if such consent and/or approval is required)).
- 7.2 In the event of an Agreed Switch and save as set out in this clause 7, all the provisions of this Agreement relating to the Scheme and the Scheme Document and its implementation shall apply to the Offer, the Offer Document and its implementation *mutatis mutandis* and the Offeror shall:
 - 7.2.1 prepare the Offer Document and related form of acceptance and shall consult with Hyve in relation to the preparation thereof;

- 7.2.2 consult with Hyve as to the timing of the publication of the Offer Document and the form of acceptance;
- 7.2.3 submit, or procure the submission of, drafts and revised drafts of the Offer Document to Hyve for review and comment, afford Hyve sufficient time to consider such documents and, where necessary, give due consideration to reasonable comments of Hyve for the purposes of preparing revised drafts;
- 7.2.4 seek Hyve's approval of the contents of the information on Hyve contained in the Offer Document before it is published, and afford Hyve sufficient time to consider such documents, in order to give its approval (such approval not to be unreasonably withheld or delayed); and
- 7.2.5 keep Hyve informed, on a regular and confidential basis, and, in any event, by 5.00 p.m. on the next Business Day following receipt of a written request from Hyve, of the number of Hyve Shareholders that have validly returned their acceptance or withdrawal forms or incorrectly completed their acceptance or withdrawal forms, the identity of such shareholders and the number of Hyve Shares to which such forms relate.
- 7.3 In the event of an Agreed Switch, unless otherwise agreed by Hyve or required by the Panel:
 - 7.3.1 the Acceptance Condition may initially be set at not more than 90 per cent. of the shares to which the Offer relates (or such lower number of shares as the Offeror may in its discretion decide);
 - 7.3.2 the Offeror shall not take any action which would cause the Offer not to proceed, to lapse or to be withdrawn, in each case for non-fulfilment of the Acceptance Condition, prior to the 60th day after publication of the Offer Document and the Offeror shall ensure that the Offer remains unconditional until such time; and
 - 7.3.3 the Offeror shall ensure that, other than the Acceptance Condition, the only conditions to the Offer shall be the Conditions (excluding the Scheme Conditions).
- 7.4 The parties agree that, in the case of any Agreed Switch, save as set out in this clause 7, all the provisions of this agreement relating to the Scheme and the Scheme Document and its implementation shall apply to the Offer, the Offer Document and its implementation *mutatis mutandis*.

8 Revisions to the Acquisition

The parties shall take all such steps as are reasonably necessary to implement any revised or amended terms of the Acquisition that have been proposed by the Offeror and which are the subject of a continued Hyve Board Recommendation and the provisions of this agreement shall apply as nearly as practicable in the same way to such revised Scheme or Offer.

9 Hyve Share Plans and employee matters

- 9.1 The parties agree that the provisions of part 1 of schedule 1 shall apply in connection with the implementation of the Acquisition in respect of the Hyve Share Plans.
- 9.2 The parties agree that the provisions of part 2 of schedule 1 shall apply in connection with the implementation of the Acquisition in respect of certain employee related matters.
- 9.3 Hyve shall determine the strategy for communicating the provisions of schedule 1, in respect of Hyve Share Plans and other employee matters, to the employees of Hyve following consultation with the Offeror in good faith.

10 **D&O** insurance

- 10.1 If and to the extent such obligations are permitted by applicable Law, for six years after the Effective Date, the Offeror undertakes in favour of Hyve and in favour of each of the directors and officers of Hyve and of each of its subsidiary undertakings as at the date of this agreement to procure that Hyve shall honour and fulfil its obligations (if any) existing at the date of this agreement regarding exclusion or limitation of liability of directors, indemnification of officers and directors and advancement of expenses with respect to matters existing or occurring at or prior to the Effective Date.
- The Offeror acknowledges that, prior to the Effective Date, Hyve may (if available on reasonable commercial terms) purchase directors' and officers' insurance for both current and former directors and officers of the Hyve Group, including without limitation directors and officers of Hyve at the date hereof who retire or whose employment is terminated on or prior to the Effective Date in connection with the Acquisition, for acts and omissions up to and including the Effective Date, in the form of run-off cover for a period of six years following the Effective Date (the "Run-Off Cover"). The Run-Off Cover shall be with reputable insurers, for an aggregate limit commensurate with Hyve Group's existing policies and provide cover substantially equivalent (including as to covered persons) to that provided under the Hyve Group's directors' and officers' insurance as at the date of this agreement. If and to the extent that Run Off Cover has not been purchased by Hyve prior to the Effective Date, the Offeror shall procure that Hyve (or a member of the Offeror Group) purchases such Run-Off Cover (if available on reasonable commercial terms) promptly following the Effective Date.
- 10.3 Each of the directors, officers and employees of the Hyve Group to which the foregoing provisions of this clause 10 apply shall have the right, pursuant to the Contracts (Rights of Third Parties) Act 1999, to enforce their rights against the Offeror or any of its successors or assigns under the foregoing provisions of this clause 10.

11 Termination

- 11.1 Subject to clause 11.2 and clause 11.3, this agreement shall be terminated with immediate effect and all rights and obligations of the parties under this agreement shall cease as follows:
 - 11.1.1 if agreed in writing between the parties at any time prior to the Effective Date;
 - if the Announcement is not released on the date of this agreement (unless, on or prior to the date of this agreement, the parties have agreed another date in accordance with clause 2 in which case the later date shall apply for the purposes of this clause 11.1.2);
 - 11.1.3 upon service of written notice by the Offeror to Hyve if a Hyve Board Recommendation Change occurs;
 - if prior to the Long Stop Date, any Condition has been invoked by the Offeror (where the invocation of the relevant Condition has been specifically permitted by the Panel);
 - if prior to the Long Stop Date, a third party announces a firm intention to make an offer or revised offer for Hyve which completes, becomes effective, or is declared or becomes unconditional in all respects;
 - if the Acquisition (whether implemented by way of the Scheme or the Offer) lapses, terminates or is withdrawn in accordance with its terms on or prior to the Long Stop Date and, where required, with the consent of the Panel (other than where such lapse or withdrawal is as a result of an Agreed Switch);
 - 11.1.7 upon service of written notice by either party to the other party if the Scheme is not approved by the requisite majorities of the holders the Scheme Shares at the Court Meeting and/or the Hyve Resolutions are not approved at the General Meeting; or

- 11.1.8 unless otherwise agreed by the parties in writing or required by the Panel, if the Effective Date has not occurred on or before the Long Stop Date.
- 11.2 Termination of this agreement shall be without prejudice to the rights of either party that may have arisen prior to termination.
- 11.3 The whole of this clause 11, clauses 12 to 25 (inclusive), and the related provisions of clause 1 shall survive termination of this agreement.
- 11.4 Subject always to clause 11.3, if this agreement is terminated in accordance with its terms on or after the Effective Date, or the date of the Offer becoming or being declared unconditional in all respects, as the case may be, clause 9, clause 10 and schedule 1 shall survive termination of this agreement, subject to any amendment as may be agreed in writing by the parties as at the date of such termination in such circumstances.

12 Representations and warranties

- 12.1 Each of the parties represents and warrants to the other on the date hereof that:
 - 12.1.1 it has the requisite power and authority to enter into and perform this agreement;
 - 12.1.2 this agreement constitutes legal, valid and binding obligations on it in accordance with its terms; and
 - 12.1.3 the execution and delivery of, and performance of its obligations under, this agreement shall not:
 - 12.1.3.1 result in a breach of any provision of its constitutional documents; or
 - 12.1.3.2 save as previously fairly disclosed to the other party, result in a breach of, or constitute a default under, any instrument to which it is a party or by which it is bound; or
 - 12.1.3.3 result in a breach of any order, judgment or decree of any court or governmental agency to which it is a party or by which it is bound.
- 12.2 The Offeror represents and warrants to Hyve on the date hereof that:
 - 12.2.1 it has the requisite power and authority to enter into and implement the Acquisition on the terms and subject to the conditions set out in the Announcement; and
 - 12.2.2 no shareholder resolution (or similar) of the Offeror or any member of the Wider Providence Group is required to enter into and implement the Acquisition.
- The Offeror acknowledges and agrees, on its own behalf and on behalf of the Wider Providence Group, that any information and/or assistance provided by any of Hyve Directors, or Hyve's officers, employees or advisers (each, a "Hyve Representative") to it, and/or any member of the Wider Providence Group or any of its respective officers, employees or advisers, whether before, on or after the date of this agreement: (i) pursuant to the obligations of Hyve or any member of Hyve Group under or otherwise in connection with this agreement; or (ii) in connection with the Acquisition, shall in each case be given on the basis that the relevant Hyve Representative shall not incur any liability nor owe any duty of care to any member of the Wider Providence Group in respect of any loss or damage that any member of the Wider Providence Group or any of its respective officers, employees or advisers may suffer as a result of the provision of any such information and/or assistance (save in each case for loss or damage resulting from the fraudulent misrepresentation of the relevant Hyve Representative). Each Hyve Representative shall have the right, pursuant to the Contracts

(Rights of Third Parties) Act 1999, to enforce their rights against the Offeror or any of its successors or assigns under this clause 12.3.

13 **Invalidity**

- 13.1 If any provision in this agreement shall be held to be illegal, invalid or unenforceable, in whole or in part, the provision shall apply with whatever deletion or modification is necessary so that the provision is legal, valid and enforceable and gives effect to the commercial intention of the parties.
- 13.2 If and to the extent it is not possible to delete or modify the provision, in whole or in part, under clause 13.1, then such provision or part of it shall, if and to the extent that it is illegal, invalid or unenforceable, be deemed not to form part of this agreement and the legality, validity and enforceability of the remainder of this agreement shall, subject to any deletion or modification made under clause 13.1, not be affected.

14 Code

- 14.1 Nothing in this agreement shall in any way limit either party's obligations under the Code and any uncontested rulings of the Panel as to the application of the Code in conflict with the terms of this agreement shall take precedence over such terms.
- The parties agree that, if the Panel determines that any provision of this agreement that requires Hyve to take or not take action, whether as a direct obligation or as a condition to any other person's obligation (however expressed), is not permitted by Rule 21.2 of the Code, that provision shall have no effect and shall be disregarded.
- 14.3 Hyve confirms to the Offeror that Hyve's current intention is that, prior to the Effective Date but not more than five Business Days before the Effective Date, Hyve Enterprises Ltd (or another member of the Group on its behalf) will make a voluntary prepayment to the Facility B Lenders under and as defined in the Senior Facility Agreement in an amount equal to 10% of the Total Facility B Commitments (as defined in the Senior Facility Agreement) as at the date of the prepayment, together with all accrued but unpaid interest thereon. The Offeror consents to such prepayment for the purpose of Rule 21.1 of the Code.

15 Notices

- 15.1 Any notice or other communication given in connection with this agreement (each, a "**Notice**") shall be:
 - 15.1.1 in writing;
 - 15.1.2 in English; and
 - delivered by hand, email, pre-paid recorded delivery, pre-paid special delivery or courier using an internationally recognised courier company (provided that any notice delivered otherwise than by email to a party shall in any event also be sent to the email address specified for that party in clauses 15.2 and 15.3, as applicable, with a copy (which shall not constitute Notice) by email to that party's advisers as specified therein).
- 15.2 A Notice to the Offeror shall be sent to the following address, or such other person or address as the Offeror may notify to Hyve from time to time:

- 15.4 Each party shall notify the other in writing of any change to its notice details for the purposes of this clause 15 from time to time.
- 15.5 A Notice shall be effective upon receipt and shall be deemed to have been received:
 - at 9.00 a.m. on the second Business Day after posting or at the time recorded by the delivery service;
 - 15.5.2 at the time of delivery, if delivered by hand or courier; or
 - at the time the email is sent, if sent by email, provided that receipt shall not occur if the sender receives an automated message that the e-mail has not been delivered to the recipient.

16 Further assurances

Each party shall, and shall use reasonable endeavours to procure that any necessary third party shall, at the cost of the requesting party, from time to time, execute such documents and do such acts and things as the requesting party may reasonably require for the purpose of giving effect to this agreement to the requesting party.

17 Remedies and waivers

- 17.1 The rights and remedies provided for in this agreement are cumulative and not exclusive of any other rights or remedies, whether provided by law or otherwise.
- 17.2 No failure or delay by either party in exercising any right or remedy provided under this agreement shall operate as a waiver of it, nor shall any single or partial exercise of any right or remedy preclude any other or further exercise of it or the exercise of any other right or remedy.

- 17.3 Any waiver of a breach of this agreement shall not constitute a waiver of any subsequent breach.
- 17.4 Without prejudice to any other rights and remedies which any party may have, each party acknowledges and agrees that damages alone would not be an adequate remedy for any breach by any party of the provisions of this agreement, and any party shall be entitled to seek the remedies of injunction, specific performance and other equitable relief (and the parties shall not contest the appropriateness or availability thereof) for any threatened or actual breach of any such provision of this agreement by any party, and no proof of special damages shall be necessary for the enforcement by any party of the rights under this agreement.

18 No partnership

Nothing in this agreement and no action taken by the parties under this agreement shall be deemed to constitute a partnership between the parties nor shall constitute any party the agent of any other party for any purpose.

19 Third party rights

Save as set out in clause 10.3 and clause 12.3, a person who is not a party to this agreement has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of, or enjoy any benefit under, this agreement.

20 Variation

- 20.1 No variation of this agreement shall be effective unless in writing and signed by or on behalf of each of Hyve and the Offeror.
- 20.2 Notwithstanding clause 19, this agreement may be varied in any way without the consent of any third party beneficiary under clause 10.3 or clause 12.3, provided that the consent of each third party beneficiary under clause 10.3 or clause 12.3 shall be required for any variation of clause 10.3 or clause 12.3 at any time on or after the Effective Date.

21 Whole agreement

- 21.1 Save for the Confidentiality Agreement (which remains in force at the date of this agreement), this agreement contains the whole agreement between the parties relating to the Acquisition and supersedes any previous written or oral agreement between the parties in relation to the Acquisition.
- 21.2 Except in the case of fraud, each party agrees and acknowledges that it is entering into this agreement in reliance only upon this agreement and that it is not relying upon any precontractual statement that is not set out in this agreement.
- 21.3 Except in the case of fraud, no party shall have any right of action (including those in tort or arising under statute) against another party arising out of or in connection with any precontractual statement except to the extent that it is repeated in this agreement.
- 21.4 For the purposes of this clause 21 (*Whole agreement*), "**pre-contractual statement**" means any draft, agreement, undertaking, representation, warranty, promise, assurance or arrangement of any nature whatsoever, whether or not in writing, relating to the subject matter of this agreement made or given by any person at any time before the date of this agreement.

22 Assignment and implementation by a wholly owned bidding vehicle

22.1 Except as otherwise expressly provided in this agreement, neither the Offeror nor Hyve may assign, grant any security interest over, hold on trust or otherwise transfer the benefit of the whole or any part of this agreement, provided that the Offeror may, without the consent of Hyve, assign the benefit of the whole or any part of this agreement to any other corporate entity or other vehicle which is or may become the offeror for Code purposes and in such case

the Offeror shall procure that such other corporate entity or other vehicle shall assume the obligations of the Offeror hereunder.

22.2 The Offeror and Hyve agree that the Acquisition shall be effected by the Offeror.

23 Costs and expenses

Each party shall bear all costs incurred by it in connection with the preparation, negotiation and entry into this agreement.

24 Counterparts

This agreement may be entered into in any number of counterparts, all of which taken together shall constitute one and the same instrument. Any party may enter into this agreement by executing any such counterpart.

25 Governing law and submission to jurisdiction

- 25.1 This agreement and any non-contractual obligations arising out of or in connection with it shall be governed by and construed in accordance with English law.
- Each of the Offeror and Hyve irrevocably agrees that the courts of England and Wales are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this agreement and that accordingly any proceedings arising out of or in connection with this agreement shall be brought in such courts. Each of the Offeror and Hyve irrevocably submits to the jurisdiction of such courts and irrevocably waives any objection to proceedings in any such court on the ground of venue or on the ground that the proceedings have been brought in an inconvenient forum.

- 1.2 Hyve confirms that no additional Hyve Shares will be delivered by way of dividend equivalents in connection with any of the Hyve Share Plans prior to the Effective Date.
- 1.3 Hyve confirms that the only share incentive arrangements it operates are the Hyve Share Plans and there are no promises to grant awards or expectations that awards will be granted other than under the Hyve Share Plans and that it does not currently intend to grant any further options or awards in respect of Hyve Shares under any of the Hyve Share Plans (or otherwise) before the Effective Date.
- 1.4 The Scheme will apply to any Hyve Shares acquired by participants in the Hyve Share Plans prior to the Scheme Record Time.
- 1.5 The parties acknowledge that any bonus, vesting or exercise of awards/options or other payments described in this schedule 1 will be subject to the usual deductions for applicable taxes and national insurance / social security contributions and levies, where such taxes or contributions are required to be withheld.

2 Operation of the Hyve Share Plans

2.1 The Offeror acknowledges that, before the Effective Date but subject to this Part 1 of this Schedule 1, Hyve may continue to operate the Hyve Share Plans in the ordinary course of its

- business in accordance with this Schedule 1, the rules of the relevant Hyve Share Plan, Hyve's normal practice and subject to Rule 21 of the Code.
- 2.2 For the avoidance of doubt, subject to paragraph 1.3 above, the operation of the Hyve Share Plans as the Hyve Directors (and, where appropriate, the Hyve Remuneration Committee) consider appropriate (i) includes: issuing invitations and granting new awards in respect of any ordinary annual operation of the Hyve Share Plans and in accordance with historical practice; determining the extent to which performance conditions for outstanding awards due to vest have been satisfied (including how any such performance conditions will be tested before the Sanction Hearing), in accordance with historical practice; determining the timing and extent to which awards under the Hyve Share Plans will vest in the ordinary course; satisfying the vesting, exercise and release of awards under the Hyve Share Plans (for example, by issuing new Hyve Shares or transferring Hyve Shares from the Hyve EBT or settling awards in cash always in accordance with the rules of the relevant plan); and determining the treatment of awards held by leavers; and (ii) excludes amending the terms of any Award if the effect of such amendment is to increase the extent to which the Award would otherwise vest or, in the case of the VCP and for the avoidance of doubt, the number of VCP Shares and/or Hyve Shares that would otherwise be receivable by the participants.
- 2.3 The Offeror agrees that Hyve may amend the rules of the Hyve Share Plans if the Hyve Directors (or the relevant committee) are of the opinion that such amendments are necessary or desirable to implement the Scheme, the treatment set out in this agreement, to facilitate the administration of the Hyve Share Plans or to obtain or maintain favourable tax treatment for participants or Hyve. Hyve agrees that any such amendments shall only be made following prior consultation with Offeror, and that any representations made by the Offeror shall be considered by Hyve in good faith prior to making the implementation of any amendments.
- 2.4 The Offeror agrees that, where any of the Hyve Share Plans provide for the exercise of discretion (including in respect of performance measures), the exercise of that discretion will, subject to the terms of this agreement, be a matter solely for the Hyve Remuneration Committee.

3 Appropriate proposal to be made

- 3.1 Subject to applicable confidentiality, legal and regulatory requirements, Hyve agrees to cooperate with and provide such details to the Offeror in relation to the Hyve Share Plans as the Offeror may reasonably require in order for the parties to make appropriate proposals to the participants in the Hyve Share Plans, where and as required under Rule 15 of the Code, based on the treatment set out in paragraph 5 below (the "Proposals"). Hyve and the Offeror intend that the Proposals will be detailed within joint letters from Hyve and the Offeror to participants in the relevant Hyve Share Plans prepared by Hyve and agreed with the Offeror and distributed by Hyve at the same time as the Scheme Document is published (or such later date as Hyve and the Offeror and the Panel may agree).
- 3.2 If the Acquisition is implemented by way of a Scheme, the parties will ensure the timetable for its implementation is fixed (or the term of Awards amended) so far as possible to enable Awards granted under the relevant Hyve Share Plans which provide for vesting and/or exercise on the Effective Date to vest and/or be exercised in sufficient time to enable the resulting Hyve Shares to be bound by the Scheme on the same terms as Hyve Shares held by Hyve Shareholders.

5 Treatment of outstanding Awards under the Hyve Share Plans

 - 5.2.4 PSP Options granted on 19 January 2022: options will vest and become exercisable over a maximum of 1,136,999 Hyve Shares; and
 - 5.2.5 PSP Options granted on 9 January 2023: options will vest and become exercisable over a maximum of 1,730,000 Hyve Shares.

DSBP

5.3 All options granted under the DSBP will vest and become exercisable in full as a result of the Acquisition.

VCP

As a result of the Acquisition, the Hyve Remuneration Committee shall determine the extent to which the relevant performance conditions have been satisfied in accordance with the HHL Articles and the rules of the VCP as in force at the date of this agreement, subject to which the VCP Shares will be acquired by Hyve from VCP participants in consideration for the issue of such number of Hyve Shares as is equal to the value of the VCP Shares determined by reference to the strict formulaic application of the applicable performance conditions in the HHL Articles as in force at the date of this agreement.

6 Employee Benefit Trust

- 6.1 As at the date of this agreement, the Hyve Employee Benefit Trust (the "**Hyve EBT**") holds 646,239 Hyve Shares.
- 6.2 Subject always to Hyve's ability to make recommendations to the trustee of the Hyve EBT to use any unallocated Hyve Shares held in the Hyve EBT to satisfy awards vesting or being exercised in the normal course, Hyve intends, in priority to the issue of new Hyve Shares or the transfer out of treasury of Hyve Shares, to recommend to the trustee of the Hyve EBT that the trustee will use the Hyve Shares held in the Hyve EBT to satisfy the vesting of PSP and DSBP awards which occurs in connection with the Acquisition, and Hyve is not aware of any reason why the trustee of the Hyve EBT will not be able to act upon such a recommendation (subject to its discretion).
- 6.3 The Offeror and Hyve further agree that the trustee will be requested to use any cash it holds to: (i) satisfy any cash-settled awards and options, (ii) repay any outstanding loan to Hyve, or (iii) subscribe for new shares to satisfy outstanding awards and options.

PART 2

Employee Matters

1 Ordinary course matters

1.1 The Offeror acknowledges that prior to the Effective Date, the Hyve Group will carry out annual or other periodic pay reviews, one-off bonus awards (including awards made on hiring), appraisals and promotion rounds in the ordinary course of business and consistent with past practice.

2 Annual and periodic bonus arrangements

- 2.1 If the payment date for any Hyve annual or other periodic bonuses occurs before the Effective Date, it is acknowledged that such bonuses shall be determined by the Hyve remuneration committee and payment made in accordance with relevant Hyve policies and practices.
- 2.2 The Offeror agrees that any annual or other periodic bonuses payable in respect of the financial year in which the Effective Date occurs shall be determined and paid in accordance with the relevant Hyve policies and practices existing on the Effective Date.

3 Severance protections

- 3.1 The Offeror acknowledges and agrees that where any employee is the subject of a Qualifying Termination (as defined in paragraph 3.2 below) at any time between the Effective Date and the first anniversary of the Effective Date, the employee will be treated in a manner consistent with Hyve's past human resources practice in relation to such Qualifying Termination.
- 3.2 In this schedule 1, a "Qualifying Termination" is:
 - 3.2.1 termination of employment by the employer, but excluding where the employer is entitled pursuant to the employment contract to dismiss the employee summarily and without notice (or payment in lieu of notice);
 - 3.2.2 a termination by reason of the employee's resignation in circumstances amounting to constructive dismissal; or

a termination by reason of the employee's resignation where, without the employee's express written consent: (a) their role and/or reporting level and/or status has been materially diminished; or (b) there is a material reduction in their total compensation opportunity; or (c) their normal place of work is permanently moved to a different location and as a result their daily travelling time is increased by more than 30 minutes per day in total. 1 Introduction

The boards of Hyve Group plc ("Hyve") and Heron UK Bidco Limited ("Bidco"), a newly incorporated entity formed by funds advised by Providence Equity Partners L.L.C. for the purposes of making an offer for Hyve, are pleased to announce that they have reached agreement on the terms of a recommended cash offer for the entire issued and to be issued share capital of Hyve by Bidco (the "Acquisition").

The Acquisition is intended to be effected by means of a scheme of arrangement under Part 26 of the Companies Act (although Bidco reserves the right to effect the Acquisition by way of a Takeover Offer, with the consent of the Panel).

2 The Acquisition

Under the terms of the Acquisition, which will be subject to Conditions and further terms set out in Appendix I to this Announcement and to be set out in the Scheme Document, Hyve Shareholders will be entitled to receive:

for each Hyve Share held

108 pence in cash

The Acquisition values the entire issued and to be issued share capital of Hyve at approximately £320 million on a fully diluted basis and values Hyve at approximately £481 million on an enterprise value basis.

The Acquisition Price represents a premium of approximately:

 40.8 per cent. to the Closing Price per Hyve Share of 77 pence on 17 February 2023 (being the last Business Day prior to the movement of Hyve's share price on 20 February 2023);

- 49.4 per cent. to the three-month volume weighted average Closing Price per Hyve Share of 72 pence on 17 February 2023 (being the last Business Day prior to the movement of Hyve's share price on 20 February 2023); and
- 59.5 per cent. to the six-month volume weighted average price of 68 pence per Hyve Share to 17 February 2023 (being the last Business Day prior to the movement of Hyve's share price on 20 February 2023).

The Acquisition implies an enterprise value multiple of approximately 20.3 times Hyve's EBITDA for the 12 months to 30 September 2022.

The Hyve Shares will be acquired by Bidco fully paid and free from all liens, equitable interests, charges, encumbrances, rights of pre-emption and any other third party rights or interests whatsoever and together with all rights existing at the date of this Announcement or thereafter attaching thereto, including (without limitation) the right to receive and retain, in full, all dividends and other distributions (if any) declared, made or paid or any other return of capital (whether by way of reduction of share capital or share premium account or otherwise) made on or after the date of this Announcement in respect of the Hyve Shares.

If any dividend and/or other distribution and/or other return of capital is declared, made, or paid or becomes payable in respect of Hyve Shares on or after the date of this Announcement and prior to the Effective Date, Bidco reserves the right to reduce the consideration payable by it pursuant to the Acquisition by an amount up to the aggregate amount of such dividend and/or other distribution and/or other return of capital, in which case any reference in this Announcement or in the Scheme Document to the consideration payable under the terms of the Acquisition will be deemed to be a reference to the consideration so reduced. In such circumstances, Hyve Shareholders will be entitled to retain any such dividend, distribution or other return of value declared or paid.

It is currently expected that the Scheme Document will be published as soon as reasonably practicable and, in any event, within 28 days of this Announcement, that the Court Meeting and the General Meeting will be held as soon as possible thereafter following the required notice period for the Meetings and that, subject to the satisfaction or waiver of all relevant Conditions and the further terms set out in Appendix I to this Announcement and to be set out in the Scheme Document, the Scheme is expected to become effective in May 2023.

3 Background to and reasons for the Acquisition

Providence believes that Hyve has established a strong platform for future organic and inorganic growth underpinned by Hyve's portfolio of high-quality global brands and market-leading events focused on developed markets and in growing sectors.

Hyve has consistently delivered industry-leading like-for-like organic growth, driven by its centralised model of best practice along with new launches, geo-clones and product extensions. Hyve also has a proven track record of identifying and successfully executing accretive, product-led acquisitions, which have both added to Hyve's existing portfolio and supported its digital diversification strategy.

Providence is a highly experienced investor in the events sector having been the majority shareholder of CloserStill Media since 2018, and having previously invested in Clarion Events and GLM.

Providence believes that it is uniquely placed to support Hyve in the next stage of Hyve's development as a standalone business by leveraging its knowledge and experience of the industry, and by providing the capital necessary to accelerate, both organically and via value-enhancing acquisitions, Hyve's omnichannel strategy, thereby realising Hyve's full growth potential.

4 Recommendation

The Hyve Directors, who have been so advised by Goldman Sachs International and Numis as to the financial terms of the Acquisition, consider the terms of the Acquisition to be fair and reasonable. In providing their financial advice to the Hyve Directors, Goldman Sachs International and Numis have taken into account the commercial assessments of the Hyve Directors.

Accordingly, the Hyve Directors intend to recommend unanimously that Hyve Shareholders vote in favour of the Scheme at the Court Meeting and the resolution to be proposed at the General Meeting. The Hyve Directors who hold Hyve Shares have irrevocably undertaken to vote in favour of the Scheme at the Court Meeting and the resolution to be proposed at the General Meeting in respect of their own beneficial holdings, amounting in aggregate to 1,576,389 Hyve Shares and representing approximately 0.54 per cent. of the issued share capital of Hyve as at 14 March 2023 (being the latest practicable date prior to publication of this Announcement). In addition, certain of these Hyve Directors have also irrevocably undertaken to procure that members of their immediate families and related trusts, who have beneficial holdings in aggregate of 39,771 Hyve Shares representing approximately 0.01 per cent. of the issued share capital of Hyve as at 14 March 2023 (being the latest practicable date prior to publication of this Announcement), vote in favour of the Scheme at the Court Meeting and the resolution to be proposed at the General Meeting. These irrevocable undertakings remain binding in the event of a competing offer.

5 Letter of intent

Bidco has received a non-binding letter of intent from Strategic Value Partners, L.L.C., a Hyve Shareholder which holds, in aggregate, 47,775,625 Hyve Shares representing approximately 16.38 per cent. of the existing issued share capital of Hyve stating their intentions to vote in favour of the Scheme at the Court Meeting and the General Meeting.

Therefore, Bidco has received irrevocable undertakings from the Hyve Directors (and where applicable their immediate family members and related trusts) or a letter of intent from other Hyve Shareholders, with respect to, in aggregate, 49,391,785 Hyve Shares representing approximately 16.94 per cent. of the existing issued share capital of Hyve.

Further details of these irrevocable undertakings and the letter of intent are set out in Appendix III to this Announcement.

6 Background to and reasons for the Recommendation

Hyve is a next-generation events business with a clear ambition and strategy to unite industry communities through its omnichannel platforms and contribute to shaping their future. Through the completion of an ambitious transformation programme that began in 2017, Hyve has combined a differentiated approach and model, a strategy focused on digital-ready and growing sectors, and a focus on connecting whole industry ecosystems

through in-person events and both online and meeting platforms. This combination has created an established platform for growth with large-scale, market leading, high-quality global brands in advanced economies and in key sectors with strong future growth trajectories.

Hyve has undergone significant change since the launch of the Transformation and Growth (TAG) programme in 2017 and has become a fundamentally different business that continues to evolve and transform through a focus on three areas:

- creating a scalable platform through the implementation of a centralised operating model which drives global consistency through best practices across every team and event. This has led to industry-leading like-for-like organic growth;
- managing the portfolio to focus on global, market-leading events with high growth potential which would benefit from a centralised operating model. The number of Hyve's events has reduced during the TAG programme from 269 to 130 with average revenue per event more than trebling. Following the Russian invasion of Ukraine and disposal of Hyve's Russian business and other non-core businesses, Hyve currently holds 33 inperson events with a more than eight-fold increase in revenue; and
- making product-led acquisitions to strengthen the portfolio and increase average revenue. Examples include Spring Fair, Bett, Mining Indaba, and, more recently, Shoptalk, Retail Meetup and 121 Group.

Through the continuation of this strategy of focusing on market leading brands, launching new events and geo-clones, and making strategic acquisitions of market-leading brands, Hyve is now strategically well positioned to capture its growth potential. The business is focused on its divisions of RetailTech & FinTech, EdTech & Natural Resources and Retail, Manufacturing & Engineering with all events operating with a centralised model of best practice. Digital diversification has created further opportunities to diversify Hyve's portfolio with data-driven and tech enabled products. Combined with a strong, committed team with a proven track recovery of delivery, and recent greater financial stability and visibility, the Board of Hyve believes the business is positioned for organic growth and, if access to appropriate capital is available for strategic acquisitions, has confidence in Hyve's ability to capture and drive value from its prospects and deliver long-term value for all our stakeholders.

COVID-19 and the Russian invasion of Ukraine represented significant recent challenges to the business, including a material and sustained decline in Hyve's share price as well as an increase in Hyve's leverage position. The business has since performed well in its recovery from the impact of COVID and executed a refinancing of its debt in late 2022, although market conditions meant that the cost of Hyve's debt increased significantly. Hyve has also navigated these challenges in a way to create opportunities to accelerate the development of Hyve with the portfolio of events optimised and almost 95 per cent. now in advanced economies following the disposal of Hyve's Russian business and other non-core businesses. Challenges and constraints, in particular related to the access to capital and ability to attract and retain talent, are anticipated to persist and will impact the scale of the future opportunity available to Hyve and the pace of the continued evolution and transformation of the business required to ensure continued leadership over industry peers. This is especially relevant as the industry continues to evolve in light of technological change and against a challenging macroeconomic backdrop.

The Board of Hyve did not solicit an offer for Hyve. However, the Board of Hyve regularly considers all options for driving and improving shareholder value. The initial unsolicited

proposals received from Providence at 101 pence and 105 pence per Hyve Share were not at a level that the Board of Hyve felt adequately reflected an appropriate valuation of Hyve and its future prospects. After Providence's third proposal of 108 pence per Hyve Share in cash, the Board of Hyve felt that the proposal from Providence required more detailed consideration.

In considering the financial terms of the Acquisition and determining whether they reflect an appropriate valuation of Hyve and its future prospects, the Board of Hyve took into account a number of factors including that:

- the Acquisition reflects the strength of the Hyve businesses and its future prospects, and provides an opportunity for Hyve Shareholders to crystallise, in cash, the value of their investments at a fair and reasonable value;
- the Acquisition Price represents an attractive premium of 40.8 per cent. to the Closing Price on 17 February 2023 (being the last Business Day before the movement of Hyve's share price on 20 February 2023), 49.4 per cent. to the volume weighted average closing price in the three months to 17 February 2023, and 59.5 per cent. to the volume weighted average closing price in the six months to 17 February 2023;
- the Acquisition Price implies an enterprise value multiple of approximately 20.3 times Hyve's EBITDA for the 12 months ended 30 September 2022;
- the certainty of the Acquisition should be weighed against the inherent uncertainty of the delivery of future value that exists in the business; and
- the Acquisition delivers more risk-adjusted immediate value to Hyve Shareholders than other options considered by and currently available to the Board of Hyve.

In considering the Acquisition, the Board of Hyve has taken into account Providence's stated intentions for the business and its employees.

Following careful consideration of the financial terms of the Acquisition, the combination of value and certainty that the terms of the Acquisition provides to shareholders, and the above factors, the Board of Hyve intends to recommend unanimously the Acquisition to Hyve Shareholders. The Hyve Directors who hold or are beneficially entitled to Hyve Shares (and where applicable their immediate family members and related trusts) have each irrevocably undertaken to vote in favour of the Scheme at the Court Meeting and in favour of the Resolution to be proposed at the General Meeting in respect of all their Hyve Shares, being in aggregate a total of 1,616,160 Hyve Shares (representing approximately 0.55 per cent. of the ordinary share capital of Hyve).

7 Information on Providence and Bidco

Providence is a specialist private equity investment firm focused on growth-oriented media, communications, education, and technology companies across North America and Europe. Providence combines its partnership approach to investing with deep industry expertise to help management teams build exceptional businesses and generate attractive returns. Since its founding in 1989, Providence has invested over \$32 billion across more than 170 private equity portfolio companies.

Bidco is a newly established limited company formed by Providence for the purposes of the Acquisition. Bidco has not traded since its date of incorporation, nor has it entered into any obligations other than in connection with the Acquisition. Further details in relation to Bidco will be contained in the Scheme Document.

8 Information on Hyve

Hyve is a next-generation global events business whose purpose is to bring together and connect entire sector ecosystems from all corners of the globe and whose vision is to deliver game-changing impact to its customers by redefining events, and use its influential voice to create platforms for progress in the sectors it works within. Hyve meets its customers' needs to learn, network and trade via unmissable in-person events, online platforms and hyper-productive meeting programmes delivered with globally consistent best practice and unrivalled quality.

Hyve's global portfolio of market leading brands is divided across four divisions: RetailTech & FinTech, EdTech & Natural Resources and Retail, Manufacturing & Engineering and Asia. The portfolio consists of 33 in-person events and 23 tech-enabled products and includes brands such as: Shoptalk, Spring Fair, Bett, Mining Indaba, and the recently acquired Fintech Meetup.

Strategic plans for the Hyve Group

Following completion of the Acquisition, Bidco intends to support Hyve by leveraging its industry experience in providing the capital necessary to accelerate Hyve's strategy. Bidco fully supports management's compelling vision of delivering real impact by redefining events to maximise the power of human connections. Bidco supports the execution of this vision through driving organic growth, investing in further digitisation and by pursuing strategic acquisitions in new and existing growth sectors.

Providence recognises and values the distinct strategic, product and operational positioning of Hyve and the expertise of its management team and employees. Providence has no intention of merging or in any form combining Hyve with CloserStill Media or any other current portfolio company of Providence.

Employees and management

Hyve has a strong team of talented and committed employees who have worked hard to transform. Hyve into an ambitious, market-leading and innovative business. Bidco recognises the high quality of the employees and the strength of the management team at Hyve and their importance to the success of Hyve following the Acquisition. Bidco believes that they will be a key factor in maximising the future success and realising Hyve's vision and full growth potential.

Bidco does not intend that there will be any headcount reductions as a result of the Acquisition, except that there may be reductions in respect of certain corporate and support functions which are currently required to support Hyve's public listing. Bidco, with the support and guidance of Hyve's management, intends to seek to provide alternative opportunities within Hyve to all employees currently in these roles. At this stage, Bidco has not yet developed proposals as to how any headcount reductions that may arise in relation to such functions could be implemented and will only develop and implement such proposals in coordination with Hyve's management. Any individuals who are affected will be treated in a manner consistent with the high standards, culture and practices of Hyve.

Bidco confirms that, following completion of the Acquisition, the existing contractual and statutory rights and terms and conditions of employment, including pension obligations, of the management and employees of the Hyve Group will be fully safeguarded in accordance with applicable law.

Bidco has no intention to make any material change to the conditions of employment of Hyve employees or in the balance of the skills and functions of the employees and management of Hyve.

Following completion of the Acquisition, Bidco intends to put in place incentivisation arrangements for managers and employees of Hyve. However, Bidco has not entered into, and has not had discussions on proposals to enter into, any form of incentivisation arrangement with any member of Hyve's management or with any Hyve employee, nor will it enter into any such discussions prior to the completion of the Acquisition.

Bidco expects that Hyve's non-executive directors will resign from the board of Hyve upon completion of the Acquisition.

Locations, headquarters and research and development

Bidco has no plans to change the locations of Hyve's places of business or headquarters. Hyve does not currently have a research and development function and Bidco has no plans in this regard. Bidco has no intention to redeploy the fixed assets of Hyve.

Pension schemes

No member of the Hyve Group participates in any defined benefit pension schemes.

Trading Facilities

Hyve is currently admitted to listing on the Official List and to trading on the London Stock Exchange's Main Market for listed securities. As set out in paragraph 16 below, requests will be made to the FCA to de-list Hyve from the Official List, to the London Stock Exchange to cancel trading in Hyve Shares and steps will be taken to re-register it as a private company.

Post-offer undertakings

No statements in this paragraph 9 are "post-offer undertakings" for the purposes of Rule 19.5 of the Code.

10 **Hyve Share Plans**

Participants in the Hyve Share Plans will be contacted regarding the effect of the Acquisition on their rights under the Hyve Share Plans and an appropriate proposal will be made to such participants which reflects their rights under the Hyve Share Plans in due course.

11 Hyve current trading

Hyve has continued to trade well in the first half of the financial year to date and expectations for the full year remain in line with the Board's expectations. As previously announced, Hyve will provide its scheduled trading update for the first half of the financial year at the end of March.

12 Financing

The cash consideration payable by Bidco pursuant to the Acquisition will be funded from equity financing drawn down from the Providence Equity Funds. Bidco may raise debt financing in connection with the Acquisition following the date of this Announcement.

Further information regarding these arrangements will be included in the Scheme Document.

Perella Weinberg Partners and Deutsche Bank, financial advisers to Providence Equity Partners L.L.C. and Bidco, are satisfied that the resources available to Bidco are sufficient to enable Bidco to satisfy in full the cash consideration payable to Hyve Shareholders under the terms of the Acquisition.

13 Offer-related Arrangements

Confidentiality Agreement

Pursuant to the Confidentiality Agreement, Providence Equity LLP and Hyve have both undertaken to keep, and to procure that certain of their respective representatives keep, confidential information relating to (amongst other things) Hyve, Providence Equity LLP and/or to the Acquisition, to use such information solely for the agreed purposes in relation to the Acquisition and not to disclose it to third parties (with certain exceptions). These confidentiality obligations will remain in force until 13 August 2024 (or, if earlier, completion of the Acquisition). The Confidentiality Agreement contains standstill provisions which restrict Providence Equity LLP and its affiliates from acquiring or offering to acquire interests in certain securities of Hyve for a period of 12 months from the date of the Confidentiality Agreement which ceased to apply on the making of this Announcement.

Under the Confidentiality Agreement, neither party nor its affiliates may, during the period of 12 months from the date of the Confidentiality Agreement, solicit, interfere or endeavour to entice away from the other party (or knowingly offer to employ, or aid or assist in or procure the employment by any other person of) any person who at the date of the Confidentiality Agreement or during the discussions relating to the Acquisition is a director or senior management employee of the other party. The non-solicitation provision is subject to customary exclusions such as in respect of responses to non-targeted advertisements and the recruitment of persons through an employment agency.

Co-operation Agreement

Pursuant to the Co-operation Agreement, Bidco and Hyve have agreed to co-operate and provide each other with reasonable information and assistance in relation to any filings, submissions and notifications in relation to the satisfaction of Conditions 3(a) to 3(d) as set out in Appendix I to this Announcement (if and to the extent that, in the case of Conditions 3(b) to 3(d), the relevant third party under that Condition is a regulatory authority). Bidco has also agreed to provide Hyve with such information, assistance and access as may reasonably be required for the preparation of the Scheme Document.

The Co-operation Agreement records Bidco and Hyve's intention to implement the Acquisition by way of a Scheme, subject to the ability of Bidco to implement the Acquisition by way of a Takeover Offer in the circumstances described in the Co-operation Agreement.

The Co-operation Agreement will terminate in certain circumstances, including (but not limited to):

- upon service of written notice by Bidco to Hyve if the Hyve Directors make a change to their recommendation;
- if prior to the Long Stop Date, either: (i) a Condition has been invoked by Bidco (with the consent of the Panel); or (ii) a competing offer is announced which completes, becomes effective, or is declared or becomes unconditional;
- upon service of written notice by either party to the other party if the Scheme is not approved by the requisite majorities of the holders the Scheme Shares at the Court Meeting and/or the resolution is not approved at the General Meeting;
- if the Acquisition (whether implemented by way of the Scheme or a Takeover Offer) lapses, terminates or is withdrawn in accordance with its terms on or prior to the Long Stop Date and, where required, with the consent of the Panel (other than where such lapse or withdrawal is as a result of an agreed switch to a Takeover Offer); or
- unless otherwise agreed by Bidco and Hyve, the Effective Date has not occurred before the Long Stop Date.

The Co-operation Agreement also contains provisions that will apply in respect of the Hyve Share Plans and the treatment of Hyve employees.

14 Structure of the Acquisition

It is intended that the Acquisition will be effected by means of a Court-approved scheme of arrangement between Hyve and Scheme Shareholders under Part 26 of the Companies Act. Bidco reserves the right to elect to implement the Acquisition by way of a Takeover Offer (with the consent of the Panel and subject to the terms of the Co-operation Agreement).

The purpose of the Scheme is to provide for Bidco to become the holder of the entire issued and to be issued share capital of Hyve.

The Scheme is an arrangement between Hyve and the Scheme Shareholders pursuant to which the Scheme Shares will be transferred to Bidco in consideration for which the Scheme Shareholders will receive cash consideration on the basis set out in paragraph 2 above.

The Acquisition will be put to Hyve Shareholders at the Court Meeting and at the General Meeting. In order to become effective, the Scheme must be approved by a majority in number of the Hyve Shareholders voting (and entitled to vote) at the Court Meeting, either in person or by proxy, representing not less than 75 per cent. in value of the Hyve Shares voted. In addition, at the General Meeting a special resolution to approve the adoption of the Amended Hyve Articles must be passed by Hyve Shareholders representing at least 75 per cent. of the votes validly cast on that resolution. The General Meeting will be held immediately after the Court Meeting.

Following the Meetings, the Scheme must be sanctioned by the Court. The Scheme will only become effective once a copy of the Court Order is delivered to the Registrar of Companies. Upon the Scheme becoming effective, it will be binding on all Hyve Shareholders, whether or not they attended or voted at the Meetings (and, if they attended and voted, whether or

not they voted in favour). Subject to the satisfaction of the Conditions, the Scheme is expected to become effective in May 2023.

Any Hyve Shares issued before the Scheme Record Time will be subject to the terms of the Scheme. Any Hyve Shares issued at or after the Scheme Record Time will be subject to the Amended Hyve Articles and be automatically transferred to Bidco.

The Acquisition will lapse if the Scheme does not become effective by the Long Stop Date.

Upon the Scheme becoming effective, it will be binding on all Hyve Shareholders, whether or not they attended or voted at the Court Meeting or the General Meeting.

Further details of the Scheme, including an indicative timetable for its implementation and the necessary action to be taken by Hyve Shareholders, will be set out in the Scheme Document, which is expected to be dispatched to Hyve Shareholders as soon as reasonably practicable and, in any event, within 28 days of the date of this Announcement (or such later date as may be agreed with the Panel).

15 Conditions

In addition to the requirements described in paragraph 14 above, the Acquisition will be subject to the Conditions and further terms set out below and in Appendix I to this Announcement and to be set out in the Scheme Document and will only become effective if, among other things, anti-trust clearance in the United States has been received (insofar as required).

The Scheme will lapse if:

- the Court Meeting and the General Meeting are not held on or before the 22nd day after
 the expected date of such Court Meeting and General Meeting to be set out in the
 Scheme Document in due course (or such later date (if any) as may be agreed by Bidco
 and Hyve and, if required, the Court may allow);
- the Court Hearing is not held on or before the 22nd day after the expected date of the Court Hearing to be set out in the Scheme Document in due course (or such later date (if any) as may be agreed by Bidco and Hyve and, if required, the Court may allow); or
- the Scheme does not become effective by the Long Stop Date.

The deadlines for the timing of the Court Meeting, the General Meeting and the Court Hearing as set out above may be waived by Bidco, and the deadline for the Scheme to become effective may be extended by agreement between Hyve and Bidco.

16 **De-listing and re-registration**

Prior to the Scheme becoming effective, Hyve will make an application to the FCA for the cancellation of the listing of Hyve Shares on the Official List and to the London Stock Exchange for the cancellation of trading of Hyve Shares on its Main Market for listed securities, in each case to take effect from or shortly after the Effective Date.

On the Effective Date, share certificates in respect of Hyve Shares will cease to be valid and should be destroyed. In addition, entitlements to Hyve Shares held within the CREST system will be cancelled.

It is also proposed that, following the Effective Date and after its shares are delisted, Hyve will be re-registered as a private limited company.

17 Disclosure of interests in Hyve Shares

As at the close of business on 14 March 2023 (being the latest practicable date prior to the date of this Announcement) neither Bidco, its directors, nor, so far as Bidco is aware, any person acting in concert (within the meaning of the Code) with it (i) has any interest in or right to subscribe for any relevant securities of Hyve, or (ii) has any short positions in respect of relevant securities of Hyve (whether conditional or absolute and whether in the money or otherwise), including any short position under a derivative, any agreement to sell or any delivery obligation or right to require another person to purchase or take delivery, or (iii) has borrowed or lent any relevant securities of Hyve (including, for these purposes, any financial collateral arrangements of the kind referred to in Note 4 on Rule 4.6 of the Code) save for any borrowed shares which have been either on-lent or resold, or (iv) is a party to any dealing arrangement of the kind referred to in Note 11 on the definition of acting in concert in the Code.

18 Dividends

If any dividend and/or other distribution and/or other return of capital is declared, made, or paid or becomes payable in respect of Hyve Shares on or after the date of this Announcement and prior to the Effective Date, Bidco reserves the right to reduce the consideration payable by it pursuant to the Acquisition by an amount up to the aggregate amount of such dividend and/or other distribution and/or other return of capital, in which case any reference in this Announcement or in the Scheme Document to the consideration payable under the terms of the Acquisition will be deemed to be a reference to the consideration so reduced. In such circumstances, Hyve Shareholders will be entitled to retain any such dividend, distribution or other return of value declared or paid.

19 Overseas Shareholders

The availability of the Acquisition and the distribution of this Announcement to persons not resident in the United Kingdom may be affected by the laws and regulations of the relevant jurisdiction. Such persons should inform themselves about, and observe, any applicable legal or regulatory requirements. Hyve Shareholders who are in any doubt regarding such matters should consult an appropriate independent professional adviser in the relevant jurisdiction without delay.

This Announcement does not constitute an offer for sale of any securities or an offer or an invitation to purchase any securities. Hyve Shareholders are advised to read carefully the Scheme Document and the forms of proxy once these have been dispatched.

20 General

Bidco reserves the right, subject to the prior consent of the Panel and subject to the terms of the Co-operation Agreement, to elect to implement the Acquisition by way of a Takeover Offer for the entire issued and to be issued share capital of Hyve not already held by Bidco, as an alternative to the Scheme. In such an event, such offer will be implemented on the same terms (subject to appropriate amendments as described in Part B of Appendix I), so far as applicable, as those which would apply to the Scheme.

If the Acquisition is effected by way of a Takeover Offer and such offer becomes or is declared unconditional and sufficient acceptances are received, Bidco intends to exercise its rights to apply the provisions of Chapter 3 of Part 28 of the Companies Act to acquire compulsorily the remaining Hyve Shares in respect of which the Takeover Offer has not been accepted.

Investors should be aware that Bidco may purchase Hyve Shares otherwise than under any Takeover Offer or scheme of arrangement relating to the Acquisition, such as in open market or privately negotiated purchases.

Perella Weinberg Partners, Deutsche Bank, Goldman Sachs International and Numis have given and not withdrawn their consent to the publication of this Announcement with the inclusion herein of the references to their respective names, in each case, in the form and context in which they appear.

- (iii) no enquiry, review or investigation by, or complaint or reference to, any Third Party against or in respect of any member of the Wider Hyve Group having been threatened, announced or instituted or remaining outstanding by, against or in respect of any member of the Wider Hyve Group, in each case which has had or might reasonably be expected to have a material adverse effect on the Wider Hyve Group taken as a whole;
- (iv) no contingent or other liability having arisen or become apparent to Bidco or increased which has had or might reasonably be expected to have an adverse effect on the Wider Hyve Group taken as a whole;
- (v) no member of the Wider Hyve Group having conducted its business in breach of any applicable laws and regulations and which is material in the context of the Wider Hyve Group as a whole; and
- (vi) no steps having been taken and no omissions having been made which are reasonably likely to result in the withdrawal, cancellation, termination or modification of any licence held by any member of the Wider Hyve Group which is necessary for the proper carrying on of its business and the withdrawal, cancellation, termination or modification of which has had, or might reasonably be expected to have, a material adverse effect on the Wider Hyve Group taken as a whole;

- 2 Except as set out in paragraph 1(a) above, the Conditions in paragraphs 1 and 2 of Part A of this Appendix I may not be waived.
- Bidco will be under no obligation to waive (if capable of waiver), to determine to be or remain satisfied or to treat as fulfilled any of the Conditions set out in paragraphs 3(a) to 3(i) of Part A of this Appendix I (inclusive) by a date earlier than the latest date for the fulfilment or waiver of that Condition specified above, notwithstanding that the other Conditions may at such earlier date have been waived or fulfilled and that there are at such earlier date no circumstances indicating that any of such Conditions may not be capable of fulfilment.
- 4 Under Rule 13.5(a) of the Code, Bidco may not invoke a Condition so as to cause the Acquisition not to proceed, to lapse or to be withdrawn unless the circumstances which give rise to the right to invoke the Condition are of material significance to Bidco in the context of the Acquisition. Bidco. Conditions 1 and 2 of Part A of this Appendix I are not subject to this provision of the Code.

- The Hyve Shares acquired under the Acquisition will be acquired fully paid and free from all liens, equities, charges, encumbrances, options, rights of pre-emption and any other third party rights and interests of any nature and together with all rights now or hereafter attaching or accruing to them, including, without limitation, voting rights and the right to receive and retain in full all dividends and other distributions (if any) declared, made or paid, or any other return of value (whether by reduction of share capital or share premium account or otherwise) made on or after the Announcement Date and before the Effective Date.
- If, on or after the Announcement Date and prior to or on the Effective Date, any dividend, distribution or other return of value is declared, paid or made or becomes payable by Hyve with a record date prior to or on the Effective Date, Bidco reserves the right (without prejudice to any right of Bidco, with the consent of the Panel, to invoke the Condition set out in paragraph 3(f)(ii) of Part A of this Appendix I) to reduce the consideration payable under the Acquisition to reflect the aggregate amount of such dividend, distribution or other return of value. In such circumstances, Hyve Shareholders would be entitled to receive and retain any such dividend, distribution or other return of value declared, made or paid.

If and to the extent that any such dividend, distribution or other return of value is paid or made on or prior to the Effective Date and Bidco exercises its rights under this paragraph 7 to reduce the consideration payable under the Acquisition, any reference in this Announcement to the consideration payable under the terms of the Acquisition will be deemed to be a reference to the consideration as so reduced.

If and to the extent that any such dividend, distribution or other return of value has been declared or announced but not paid or made or is not payable by reference to a record date on or prior to the Effective Date or the shares on which the dividend, distribution or other return of value is declared or announced will be (i) transferred pursuant to the Acquisition on a basis which entitles Bidco to receive the dividend, distribution or other return of value and to retain it; or (ii) cancelled, the consideration payable under the terms of the Acquisition will not be subject to change in accordance with this paragraph 7.

Any exercise by Bidco of its rights referred to in this paragraph 7 will be the subject of an announcement and, for the avoidance of doubt, shall not be regarded as constituting any revision or variation of the Acquisition.

- Bidco reserves the right to elect (with the consent of the Panel, and subject to the terms of the Co-operation Agreement) to implement the Acquisition by way of a Takeover Offer for the Hyve Shares as an alternative to the Scheme. In such event, the Takeover Offer will be implemented on the same terms and conditions, so far as applicable, and subject to the terms of the Co-operation Agreement, as those which would apply to the Scheme, subject to appropriate amendments including, an acceptance condition set at 90 per cent. (or such lesser number as Bidco may decide and the Panel may permit) of the Hyve Shares to which such Takeover Offer relates.
- 9 If Bidco is required by the Panel to make an offer for Hyve Shares under the provisions of Rule 9 of the Code, Bidco may make such alterations to any of the Conditions and terms of the Acquisition as are necessary to comply with the provisions of that Rule.
